## Pin Traveler Terms of Use

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you") and Pin Traveler LLC. ("Company", "we", "us", or "our"), concerning your access to and use of the <a href="https://pintraveler.net">https://pintraveler.net</a> website as well the "Pin Traveler" mobile application available in Android and iOS format as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the "Platform"). You agree that by accessing the Platform, you have read, understood, and agree to be bound by all of these Terms of Use, all applicable laws and regulations, and agree that you are responsible for compliance with any applicable local laws. The materials contained in the Platform are protected by applicable copyright and trademark law.

Accepting these Terms creates an important legal agreement between you and PIN TRAVELER with legal consequences. IF YOU DO NOT AGREE WITH ALL OF THESE TERMS, THEN YOU ARE EXPRESSLY PROHIBITED FROM USING OR ACCESSING THE PLATFORM AND YOU MUST DISCONTINUE USE IMMEDIATELY.

## 1.PLATFORM OWNER

- 1.1. The Platform is owned by Pin Traveler, LLC., a private company established at 1401 Pennsylvania Ave STE 105 Box 1748, Wilmington, DE 19806 USA. Company contact data is as follows:

- 1.2. As owner of the Platform, we reserve the right to change, modify, or remove the contents of the Platform at any time or for any reason at our sole discretion without notice and otherwise manage the Platform in a manner designed to protect our rights and property and to facilitate the proper functioning of the Platform. However, we have no obligation to update any information on our Platform. We also reserve the right to modify or discontinue all or part of the Platform without notice at any time. We will not be liable to you or any third party for any modification, price change, suspension, or discontinuance of the Platform.

# 2.SPECIAL NOTICE FOR INTERNATIONAL USE AND EXPORT CONTROLS

- 2.1. As stated above, Pin Traveler is founded in and performs its business in and according to the laws of the State of Texas, USA. Accordingly, recognizing the global nature of the Internet, those persons who choose to access the Platform from other locations do so on their own initiative and are solely responsible for compliance with local laws, if and to the extent local laws are applicable to their use of the Platform and Pin Traveler services, including as it concerns online conduct and acceptable content.
- 2.2. Any software made available in connection with the products and services provided by Pin Traveler to members and the transmission of applicable data, if any, is subject to United States export controls. No software may be downloaded from the Platform or otherwise exported or re-exported in violation of U.S. export laws.

### 3. PLATFORM REGISTRATION

- 3.1. - 3.10. The Platform gives you the option to deactivate your Member account.

  Deactivating your account will stop all services you receive on the Platform.

  However, all the data you have uploaded to the Platform, including e-mail, travel information, photographs, etc. will be kept intact. After deactivation, you will automatically signed out from all your sessions and you will not be able to sign in again to your account until you reactivate it again during sign in.
- 3.11. The Platform gives you the option to delete your account. Deleting your account will stop all services you receive on the Platform, permanently delete all the data you have uploaded to the Platform, including e-mail, travel information, photographs, etc. and profile information. However, please be aware that due to your interactions with other Members on the Platform, some information, like messages you sent to other Members and comments you have added to their photographs, may still be visible after you delete your account. Once you delete your account, there is no going back. Please be certain. We will be sorry to lose you.

- 7.1. - 9.2. With regard to Contributions, you hereby warrant that you shall comply with the following **Prohibitions**;
- 9.2.1. Your Contributions are not unsolicited or unauthorized advertising, promotional materials, pyramid schemes, chain letters, spam, junk mail, mass mailings, contests, sweepstakes or any other forms of solicitation.
- **9.2.2.** Your Contributions are not obscene, lewd, lascivious, pornographic, filthy, violent, harassing, tortious, bullying, libelous, slanderous, defamatory, or otherwise objectionable (as determined by us).
- **9.2.3.** Your Contributions do not ridicule, mock, disparage, intimidate, bully or abuse anyone.

- 9.2.4. Your Contributions are not used to harass or threaten (in the legal sense of those terms) any other person and to promote violence against a specific person or class of people and poses or creates no privacy or security risk to any person;
- 9.2.5. Your Contributions do not contain any material that solicits personal information from anyone under the age of 18 or exploits people under the age of 18 in a sexual or violent manner.
- **9.2.6.** Your Contributions do not violate any applicable law concerning child pornography, or otherwise intended to protect the health or well-being of minors.

You are solely responsible for your Contributions to the Platform and you expressly agree to exonerate us from any and all responsibility and to refrain from any legal action against us regarding your Contributions.
- 10.4. We have the right, in our sole and absolute discretion;
- 10.4.1.to edit, redact, or otherwise change any Contributions;
- 10.4.2.to re-categorize any Contributions to place them in more appropriate locations on the Platform; and
- 10.4.3.to pre-screen or delete any Contributions at any time and for any reason, without notice.
